Tech firms pivot to lateral hiring, ready-to-deploy talent

COMMON APPROACH. Shift towards niche skills hiring, especially in AI/ML and cloud

The IT sector has turned its attention towards lateral rather than fresh hires in the first three months of 2026, as per Instahyre data, as companies look to deploy experienced employees, with ready-made skills on critical projects. After enforcing opposing strategies in the past quarters, India's tech giants and mid-sized firms have arrived at a common strategy of lateral hiring.

In March, Tata Consultancy Services (TCS) sent mails to employees encouraging them to bring in "buddies" potential lateral hires to win bonus payments. Infosys is running an aggressive lateral push with over 1,000 open technical roles. Tech Mahindra faces over 1,000 delayed onboardings. Instahyre said the trend persists from Q3 when companies like Wipro added around 6,500 employees, while onboarding only around 400 freshers and cutting its FY26 fresher target to 7,500-8,000.

Meanwhile, mid-tier firms

Hexaware, Coforge, Mphasis, Persistent Systems, and KPIT reported an even sharper structural shift. Persistent Systems and KPIT are clearly experience-first, hiring for 2-15 years roles in cloud, embedded, and automotive, with fresher intake limited to around 20 niche roles or small-batch programmes.

In terms of annual hiring target as well, companies like Hexaware remain heavily lat-

eral-led, while Coforge runs at 78-82 per cent lateral hiring, with freshers forming 18-22 per cent.

LATERAL HIRING

"The pattern is consistent: lateral hiring is now the engine, freshers are the pipeline. There is a lot of high-intent hiring concentrated in AI, cloud, data, and cybersecurity, with companies prioritising ready-to-deploy talent over train-and-

deploy models," said Sarbojit Mallick, Co-Founder, Instahyre. While the trend indicates that firms are now looking for capability, Sanchit Vir Gogia, Founder and Chief Analyst at Greyhound Research said that lateral hiring comes at the cost of higher salaries.

EXPERIENCED TALENT

"As firms bring in more experienced talent, their cost base rises. At the same time, clients expect efficiency gains from AI and push for better pricing," said Gogia. Lateral talent also leads to more intense competition and over time weakens the internal pipeline for future leadership. This is why some firms are bringing freshers back but in smaller batches, through more targeted hiring and shorter, more focused training.

According to CIEL HR, there is a noticeable shift towards niche skills hiring, especially in AI/ML, cloud, cybersecurity, and data engineering. Some firms lean more aggressively into AI-focused hiring and others hire considering active project demand.

ED detects ₹36,000 crore in cybercrime proceeds across 257 cases: Govt

The Enforcement Directorate (ED) has identified proceeds of crime amounting to nearly ₹36,000 crore in 257 cybercrime cases investigated till February 28 this year, the Centre informed the Lok Sabha on Tuesday.

In a written reply, Minister of State for Home Affairs Bandi Sanjay Kumar said the agency has traced ₹35,925.58 crore linked to cyber offences under the provisions of the Prevention of Money Laundering Act (PMLA).

He noted that the ED works in close coordination with other law enforcement agencies through an established information-sharing mechanism involving designated nodal officers.

Highlighting the technological tools being used, Kumar said the ED leverages platforms such as SAHYOG, Samanvaya and the cyber police portal operated by the Indian Cyber Crime Coordination Centre under the MHA. While the ED has taken up 257 cybercrime cases so far, it does not maintain State-wise data on the proceeds of crime identified.

Nikon India eyes ₹1,000 cr revenue in FY26, 8% growth

Nikon India, a subsidiary of Japan's Nikon Corporation, is eyeing to close the financial year ending March 2026 with revenues of ₹1,000 crore, a growth of about 8 per cent from the last fiscal.

The company is expecting a steady growth of about 5 per cent in FY27, Sajjan Kumar, Managing Director, Nikon India, told *businessline* on the sidelines of Nikon Experience Zone inauguration at a retail outlet here on Tuesday.

The experience zone displays Nikon's range of photography and imaging products, including mirrorless Z camera, DSLR cameras, COOLPIX range and its Nikkor brand of lenses and accessories. This is Nikon's second experience zone in Chennai and sixth in Tamil Nadu. Across India, the company operates 140 such experience zones. On the wider camera business, Kumar said the rise of the creator economy has led to an increase in demand for photography and videography products. "Though vloggers and content creators use smart

devices when they start off, over time they migrate to Nikon when they want to upgrade as it is easier to shoot, has content clarity, and smooth update facilities," he said. Overall, Nikon has a market share of about 30 per cent in the mirrorless camera segment in India.

BEYOND CAMERAS

Beyond photography, the company also has a presence in the healthcare sector with microscopes. Kumar said that this vertical has seen significant growth in recent years and now contributes to nearly 7 per cent of the company's top line.

On the distribution front, the company sells its cameras and related accessories in over 1,500 retail outlets across the country. While it lacks a direct-to-consumer online presence, Kumar noted that 10-15 per cent of sales are estimated to come via e-commerce channels of partner distributors. On the manufacturing side, Nikon products sold in India are currently imported from Japan. The volumes do not justify local manufacturing, though the company will continue to evaluate opportunities in this area.

Prosus, Accel back 6 deep-tech start-ups under Atoms X LeapTech cohort

Global technology investor Prosus and venture capital firm Accel have unveiled six start-ups as part of the inaugural Atoms X LeapTech cohort, signalling a sharper push toward funding science-led, long-gestation innovation from India.

Selected from over 2,000 applications, the cohort focuses on "LeapTech" — a category spanning breakthroughs in climate infrastructure, space communications, aerospace systems and next-generation health-

care. The initiative is designed to back founders from "Day Zero", particularly those building in areas that require deep scientific research and long-term capital.

Under the partnership, Prosus will match Accel's investment in each company, providing founders with capital certainty as they pursue complex, high-risk ideas. The programme also offers mentorship and access to global networks.

"LeapTech requires conviction to build companies years before there is consensus. The quality of applications exceeded our expectations ... showing how Indian

founders around the world are building breakthroughs to commercialise science and create all-new categories," said Pratik Agarwal, Partner at Accel.

Ashutosh Sharma, Head of India ecosystem at Prosus, said the strong response to the inaugural cohort underscores a key gap in the ecosystem.

PATIENT CAPITAL

"Innovation in India is not constrained by ideas or inspiration. It is constrained by the right backing at the right time," he said, adding that Prosus aims to provide patient capital and global op-

erating expertise to help founders "think in decades, not quarters." The selected start-ups reflect a wide range of frontier technologies.

These include Praan, which is building full-stack air infrastructure to optimise indoor environments; QOSMIC, focused on ultra-high-speed optical communication between satellites and Earth; and Dagnosis, which is developing cancer detection using breath analysis powered by canine olfaction, robotics and AI.

Space-tech startup Etheral Exploration Guild is working on fully reusable orbital launch vehicles aimed

at sharply reducing launch costs, while Ferra is developing a guided home-based strength training system targeted at ageing populations. One start-up in the cohort remains in stealth mode and is building brain-computer interface technology.

The announcement builds on Accel's broader Atoms programme, launched in 2021, which has backed more than 50 start-ups that have collectively raised over \$300 million in follow-on funding.

With applications for future cohorts already under evaluation, the Accel-Prosus partnership reflects a growing shift in India's start-up

ecosystem toward deep-tech bets, where global capital is increasingly aligning with scientific innovation to build category-defining companies.

Meesho bets on AI voice assistant 'Vaani' to onboard next 500 m users

Meesho is positioning its newly launched AI-powered voice shopping assistant, Vaani, as a key driver to bring India's digitally hesitant consumers onto e-commerce platforms, as the company sharpens its focus on the next phase of user growth.

The Bengaluru-based firm said the assistant has already seen early traction, with 1.5 million users within a month of launch and a 22 per cent increase in conversion rates among those who engaged with it. Repeat usage trends indicate growing user comfort, pointing to habitual adoption rather than one-time experimentation.

NEW USERS

"This technology is so important for new users that we are investing in it. In the future, I expect that the orders that come through our Shopping Assistant will be a big chunk of orders from new users," said Sanjeev Kumar, Co-founder and CTO,



Meesho. The company is targeting a segment it believes remains largely underserved by digital commerce — users who are not defined by age or geography, but by their limited comfort with technology.

Meesho estimates that nearly 500 million Indians primarily use apps, such as WhatsApp, Instagram and Facebook, but find typical e-commerce interfaces complex.

Vaani aims to address this gap by replicating the conversational nature of offline shopping. Users can interact through voice, ask follow-up questions, and refine their preferences in real time, reducing reliance on typing, filters, and structured naviga-

tion. Built in-house, the assistant combines proprietary speech-to-text, a fine-tuned large language model, and a custom text-to-speech engine, layered on top of off-the-shelf LLM infrastructure. The system also uses edge computing to enable low-latency interactions and optimise costs, alongside a multi-agent framework to handle complex queries across the shopping journey.

"At Meesho, AI has always been at the core of how we build for scale. With over 251 million annual transacting users, we have a deep understanding of how India shops," Kumar said, adding that AI and machine learning are embedded across discovery, pricing, logistics, and seller growth.

The push has broader commercial implications. Meesho's user base continues to skew towards cash-on-delivery, impacting margins. Kumar indicated that conversational interfaces like Vaani could help build trust and accelerate prepaid adoption, particularly among first-time users.

J&K Bank gets ₹200 crore demand order for GST liability

The Jammu and Kashmir Bank on Tuesday said it has received a demand order for GST liability of ₹200.20 crore from the Additional Commissioner, Central GST Commissionerate, Jammu.

The demand order pertains to the period beginning from February 23, 2020 till March 2024 for transactions

under the Banks Transfer Price Mechanism (TPM), according to the private sector bank's regulatory filing.

The bank said it has a strong case on merits and has reasonable belief on the basis of expert opinion that the demand is without legal justification and will be set aside by Court of appropriate jurisdiction. The bank said it believes the demand will not have material impact on its financials, operations or other activities.

PM urges 'Team India' approach, calls for public preparedness

PTI, NEW DELHI: Prime Minister Narendra Modi on Tuesday announced the constitution of seven empowered groups to deal with the potential long-term impacts of the West Asia war and urged states to work with the Centre in a 'Team India' approach to ward off the crisis.

Observing that the situation is constantly changing in West Asia, he said its adverse effects are likely to persist for an extended time, and called upon citizens to remain prepared for every eventuality.

Flagging 'serious side effects of the war', the Prime Minister recalled the national response to Covid-19, when empowered groups of experts had helped address challenges, and said the seven empowered groups will deal with the consequences of war and evolve strategies on fuel, fertilisers, gas, supply chains and inflation.

In a statement in the Rajya Sabha, he reiterated India's position of dialogue and diplomacy as the only solutions to the restoration of peace in West Asia.

He also said India was in constant touch with all parties, including Iran, Israel and the United States, to stress de-escalation.

While admitting to the unprecedented challenges the war is posing for India in terms of supply of essential goods, including crude, gas and fertilisers, the Prime Minister said going forward "self-reliance was the only option".

Noting that the war has created a serious energy crisis globally, he also warned miscreants against taking advantage of crisis, and has asked state governments to check black marketing and hoarding.

In such a critical situation, it is essential that a united voice of peace and dialogue goes out to the entire world from this Upper House of India's Parliament, Modi said.

He asserted that the government is trying to procure gas and crude oil from

RAHUL SLAMS MODI OVER COVID REMARK, SAYS PM IGNORING PAST TRAGEDIES

PTI, NEW DELHI: Congress leader Rahul Gandhi on Tuesday attacked Prime Minister Narendra Modi for his COVID-19 reference in his statement to Parliament on the West Asia situation, saying he has forgotten what had happened during the pandemic and the kind of tragedies that had unfolded back then. Gandhi alleged that India's foreign policy has become "Modi's personal foreign policy" which is being considered as a "universal joke". Speaking with reporters in the Parliament House complex, Gandhi said, "If the PM is compromised, our foreign policy is compromised." Asked about reports of Pakistan being one of the intermediaries between the US-Israel and Iran, and India's stand on the West Asia crisis, the Leader of Opposition in the Lok Sabha said, "Our foreign policy is PM Modi's personal foreign policy. You can see the results of this, everybody considers this a universal joke." "US President Donald Trump knows exactly what Mr. Modi can do and what Mr. Modi cannot do. If the PM is compromised, our foreign policy is compromised, it is obvious," Gandhi said.

all available sources, and efforts on this front will continue in the coming days to ensure that the common people are not affected.

Modi also said necessary preparations have been made for the adequate supply of fertilisers, as he assured farmers that no burden of war falls upon them.

"The government is working with a comprehensive strategy to address every aspect of this crisis -- be it its short-term, medium-term, or long-term implications," he said.

The government, the Prime Minister said, has already constituted an inter-ministerial group, which meets regularly to assess any difficulties in import-export operations and work on devising necessary solutions.

BRS protests LPG shortage claim; govt says supply stable

PTI, HYDERABAD: Opposition BRS legislators on Tuesday held a protest here over the alleged shortage of LPG cylinders in the state, even as the government maintained that the supply was stable.

BRS MLAs, MLCs and party's Working President K T Rama Rao assembled at the Telangana Martyrs Memorial in front of the state assembly and staged the protest, holding placards shaped like gas cylinders and expressed concern over the "rising" prices.
