HDFC sells shares of Ansal Housing

HDFC Ltd on Tuesday said it has sold a portion of the shares of Ansal Housing which it had acquired after the construction company failed to pay its loan dues. Details about HDFC's loan exposure to Ansal were not provided. On June 16, HDFC informed the exchanges about invocation of 50,00,000 shares of

Ansal Housing, aggregating to 8.42 per cent of its share capital. "We wish to inform that out of these invoked shares, the Corporation has sold 15,18,633 shares representing 2.56 per cent of the paid-up share capital of Ansal...," HDFC said. The HDFC stock closed at ₹2,217.05 apiece on BSE, up 0.57 per cent and Ansal Housing ended 0.72 per cent lower at

P-notes investment drops in June New Delhi, July 19

Investment in capital markets through participatory notes (P-notes) declined to ₹80,092 crore till June-end, making it the lowest level in 20 months, on the aggressive rate hike by the US Federal Reserve. With continued global uncertainty and volatility, experts believe investment through P-notes will be volatile in the near future. The June figure also marks the second consecutive monthly decline in investment numbers. Of the total investments, ₹70,644 crore was in equities, ₹9,355 crore in debt and ₹92 crore in hybrid securities. PTI

US stocks up amid weak housing data New York, July 19

US stocks opened on an upbeat note Tuesday amid another raft of earnings reports and more signs the housing market is slowing from its torrid pace. But a Wall Street rally on Monday petered out by the end of the session, and analysts note there are competing pressures on share prices, including a report that iPhone-maker Apple plans to slow hiring and spending. About 30 minutes into the trading session, the Dow Jones gained more than one per cent to 31,072.61. The S&P 500 rose 1.2 per cent to 3,878.38, while the Nasdaq increased 1.3 per cent to 11.506.21. PNB Housing Finance, 12 others settle Carlyle case with SEBI

Issue pertains to pref allotment to US PE player

The controversy involving PNB Housing Finance's deal with US private equity player Carlyle Group has been finally put to rest. PNB Housing Finance and 12 individuals have settled their case with market regulator SEBI.

The case relates to PNB Housing Finance making a corporate announcement in May 2021, about approving the preferential issue of shares and warrants to Carlyle Group companies.

Valuation concern

After PNB Housing Finance issued shares to Carlyle, it was alleged that **PNB Housing Fin** ₹ 337 return -14% Jul 19, 22

the preferential issue lacked a registered valuer's report in accordance with the company's Articles of Association and also failed to take into account the interests of all the stakeholders by not accounting for control premium in the pricing of the preferential issue.

The preference issue of shares gave rise to a controversy as experts started questioning valuations of the shares to be offered to the investors. SEBI raised concerns and revaluation of the shares.

The deal, which could put Carlyle in the driver's seat, was scrapped after the controversy. In addition, PNB Housing Finance and the individuals involved had allegedly failed to make adequate and timely disclosures to the stock exchanges about material information.

SAT's split verdict

Subsequently, PNB Housing Finance approached the Securities Appellate Tribunal (SAT) which gave a split verdict in August 2021. Later, SEBI approached the Supreme Court in the matter. However, PNB Housing Finance, later, decided not to proceed with the preferential

The PNB HFC and the 12 individuals, who were directors of the company, jointly paid ₹72.76 lakh for settlement. The amount includes ₹44.26 lakh as legal costs, the SEBI order said.

Listed companies and individuals can settle several violations by paying a penalty "without admitting or denying the guilt". Apart from PNB Housing Fin-

ance, those who settled the case with SEBI include Rajneesh Karnatak, Sunil Kaul, Neeraj Vyas, CH SS Mallikarjuna Chandrasekaran Ramakrishnan and Gita Nayyar. Other individuals are Sudarshan Sen, Nilesh S Vikamsey, Tejendra Mohan Bhasin, Hardayal Prasad, Ashwani Kumar Gupta and Kapil Modi.

În June 2021, SEBI, through separate letters to the company and 12 individuals had sought their explanations. In response, the applicants had filed for settlement of the case.

Mitsu Chem Plast files DRHP to mop up ₹125 crore via FPO



Packaging solutions provider Mitsu Chem Plast has filed draft papers with SEBI to raise up to ₹125 crore through a follow-on public offer (FPO).

The further issue comprises 'equity shares of face value of ₹10 each aggregating up to ₹12,500 lakh," the draft red herring prospectus (DRHP) filed with Securities and Exchange Board of India (SEBI) showed.

Proceeds from the issue will be used to repay debt, fund the working capital requirements of the company and for general corporate purposes. The Maharashtra-based company posted a profit after tax of ₹11.5 crore and a total income of ₹259 crore for



the fiscal ended March 31, 2022. Mitsu Chem Plast is a packaging solutions provider engaged in the business of manufacturing polymer-based molded products mainly used for industrial packaging for industries like chemicals, agrochemicals, pharmaceuticals, lubricants, food and edible oil. It has three manufacturing units in Maharashtra with a total installed capacity of 22,857 TPA.

The NSE Nifty 50 index advanced 0.38 per cent to 16,340.55 while the BSE Sensex rose 0.45 per cent to 54,767.62, both closing at their highest since June 9. The Nifty bank index rose 1 per cent, while the auto index gained 1.1 per cent.

"Concerns over inflation data are now out of the way and the (scaled down) expectations of the US Federal Reserve rate hike are not negative for markets," said Siddhartha Khemka, head of retail research at Motilal Oswal Financial Services. "Monsoon has been progressing well, foreign investors' selling has come down .. The results season is picking up and comments and outlook from the companies will be a key driver for the markets going forward," he added.

Hindustan Unilever ended up 0.6 per cent ahead of its quarterly results, with investors looking for cues on the impact of higher inflation and demand outlook.

Re, oil are key concerns

"The depreciating currency is a concern. The bigger concern is rising crude prices, which puts a lot more pressure on the currency due to more dollar outflows,' Khemka said.

Nelco rose 5 per cent after reporting a surge in June-quarter profit. Shares of Nucleus Software Exports surged 18 per cent on the banking and financial software provider's deal with Vietnam Public Joint-stock Commercial Bank.


