Sub: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirement) Regulations, 2015, as amended ("SEBI LODR Regulations").

Ref: Our previous disclosures dated February 7, 2024, November 25, 2024, February 28, 2025, March 1, 2025 and September 27, 2025 under Regulation 30 of the SEBI LODR Regulations.

Dear Sir/Madam,

Pursuant to Regulation 30 of SEBI LODR Regulations, and in connection with the composite scheme of arrangement amongst Mangalore Chemicals & Fertilizers Limited ("MCFL"), Paradeep Phosphates Limited ("PPL") and their respective shareholders and creditors ("Scheme"), as approved by the relevant jurisdictional Hon'ble National Company Law Tribunals, we wish to inform you of the following:

- a) The Company has been informed by MCFL that Form INC-28 in respect of the Scheme has been duly e-filed by each of MCFL and PPL and that 'Effective Date 1' for the purposes of the Scheme has occurred today i.e. October 13, 2025; and
- b) After receiving the aforesaid intimation and in accordance with, and as an integral part of Scheme (i.e. Part III of the Scheme, which deals with the transfer of 2,90,37,000 equity shares of MCFL ("Identified Shares") by the Company to Zuari Maroc Phosphates Private Limited ("ZMPPL")), we confirm that the transfer of the Identified Shares of MCFL by the Company to ZMPPL ("Share Transfer") has been completed today i.e. on October 13, 2025, which is the 'Effective Date 1'. The Share Transfer has taken place as per the Scheme, at a price of INR 144 (Indian Rupees One Hundred and Forty-Four) per Identified Share, and ZMPPL has paid the Company an aggregate cash consideration of INR 418,13,28,000 (Indian Rupees Four Hundred Eighteen Crore Thirteen Lakhs Twenty-Eight Thousand) for such Share Transfer, subject to any taxes that need to be deducted at source, if any.
