'Light-touch registration soon for FPIs investing in govt bonds'

PRECISION BOOST. Trade settlement errors reduced with the T+1 cycle: SEBI official

Error rates on the settle-ment of trades for foreign portfolio investors (FPIs) have reduced under the T+1 settlement cycle from what it was under the T+2 cycle, a top regulatory official said on Thesday.

uesday. Speaking at the CII Fin-nce 3.0 Summit in Mumbai, EBI Whole-Time Member

SEBI Whole-Time Member Anarth Narayan said the reg-ulator was working on easing the PPI registration process. "We have ensured com-mon operating standards for all custodians that will do away with any regulatory ar-bitrage that was in play and are creating an online tracker to track new PPI ap-plications. A light-touch re-

gistration process will be in-troduced for FPIs that only want to invest in govern ment bonds," he said.

'Transition from a nation of savers to investors marks a paradigm shift'

Transition from a nation of savers to investors signifies a paradigm shift in India's eco-nomic and financial land-

comic and financial land-scape, according to Depalk Mohanty, Chairperson, Pen-sion Fund Regulatory and Development Authority. "The transition underway from a nation of savers to in-westors marks a paradigm shift in our economic and financial landscape. It re-flects our growing confid-ence in the financial system and its regulatory underpin-nings, improving financial nings, improving financial literacy levels, and broader Interacy levels, and broader investment opportunities", Mohanty said during the session on 'From a nation of sawers to a nation of investors-The transition' at the Financing Summit 3.0 of the Confederation of Indian Industry (CII) in Mumbai on Theader.

Mohanty highlighted that the share of cash and bank deposits in household finan-cial assets is declining, while investments in bonds and equities have been rising in equities have been rising in recent years, alongside a steady increase in financial savings for social security, such as insurance, pension, and small savings.

CROWTH TARGETS

"As we aspire to be a high-in-come country over the next 25 years, we need to grow at an average rate of around 8.0

per cent per annum. This will require commensurate levels of investment," he said, adding that the import-ance of efficient conversion of savings to capital forma-tion to meet these growth targets is crucial, underlin-ing that "to achieve an an-nual GDP growth rate of 8 per cent we need an invest-

nual GDP growth rate of 8 per cent, we need an invest-ment rate of around 36 per cent of GDP per annum." Nilesh Shah, Managing Director, Kotak Mahindra Asset Management Company pointed out that many households still believe in keeping money at home rather than in banks, and are driven by greed, highlighting the need for financial

the need for financial literacy. Vishal Kampani, Non-Ex-ecutive Vice-Chairman, JM Financial, emphasised that the transition should lead to wealth creation that benefits a broader segment of the population rather than a se-lect few.

AU SFB seeks RBI nod for transition to universal bank

AU Small Finance Bank on Tuesday submitted an ap-plication to the Reserve Bank of India to seek approval for transition from a Small Fin-ance Bank (SFB) to a univer-

sal bank.

This application comes in the backdrop of Fincare Small Finance Bank amalgamating with and into AU SFB with effect from April J. 2024, marking the first such consolidation in the SFB

space.

"This strategic evolution will pave the way for our future growth, enhance our brand presence, reduce regulatory constraints, and improve operational efficiency," said Sanjay Agarwal. prove operational effi-ciency," said Sanjay Agarwal, Founder, MD & CEO of AU

SFB. In April 2024, the RBI is-sued a circular allowing the voluntary transition of Small Finance Banks to Universal Banks and AU SFB is the first

Banks and AU SFB is the first Bank to seek regulatory ap-proval for the transition. To qualify, as per the RBI guidelines, SFBs need a five-year track record, strong fin-ancials, and a stock exchange listing among various other parameters. As of June, AU SFB's de-posits and advances stood at 879,280 crore and 789,792 crore, respectively. The net profit at 7803 crore in Q1FY25 grew 30 per cent y-oy compared to \$387 crore in Q1FY24.

Grievances in the life insurance sector are about the product itself: IRDAI member

Insurance companies must reduce the number of policyholder complaints and also ensure that the subscriber gets the facilities they expect at the time of buying the policy, said Satyajir Tripathy, Member (Distribution), IRDAI.

Referring to the three parts of insurance — pricing based on the actuarial calculation, the development and design of the product, and fidesign of the product, and mally selling the product, Tri-pathy said: "Having sold the product, what are the kind of grievances that come to the regulator? Very frankly, the grievances that are raised against life and non-life com panies are totally different.

"So when we talk about the next boom, the issue starts from the bottom, in the sense that from the end of the

PRODUCT ISSUES

Speaking at CII's Financing 3.0 Summit, the IRDAI mem-ber said the grievances in the life insurance sector are not about the claim amount or the time taken for settle-ment, but about the product itself. "In case of death... the claim amount comes. That is not a grouse. The grouse is about the misselling of a product. And I must say that it is at an alarming level. It has caught the attention of the policymakers. The policy makers are very concerned and they want this to be

"The insurance industry can-not move on to the next level of penetration or growth without addressing the poor customer experience... The life industry needs to focus on protection products... To measure insurance penetra-tion, instead of looking at premiums paid by GDP, we should be looking at the sum

assured (benefit customers get) by GDP and the sumassured by population.
"When it comes to health insurance, policy holder needs certainty in settlement of claims... The industry can look at an awareness cam-paign to make policyholders aware of medical conditions and exclusions," she said.

6 women among 9 Naxals gunned down in Bastar

Naxalites, including six women, were killed in a fierce encounter with security forces in Chhattisgarh's Bastar region on Tuesday, a top police official said, in the latest offensive against Maoists which has gathered pace after a change of government last year.

The gunfight broke out at around 10:30 am in forests along the border of Dantewada and Bijapur districts when a joint team of security forces was out on anti-Naxal operation, Inspector General of Police, Bastar Range, Sundarraj P told PTI.

Personnel belonging to the state police's District Reserve Guard (DRG), Bastar Fighters and 111th and 230th battalions of the Central Reserve Police Force (CRPF) were involved in the operation.

The operation was launched on Monday night based on inputs about the

After the guns fell silent, bodies of nine Naxalites, including six women - all clad in 'uniform' - were recovered from the spot, informed the senior IPS officer.

> Chief Minister Vishnu Deo Sai hailed security forces for their latest success against Maoists and asserted his government has resolved to end the Left-wing extremism by March 2026.

> A cache of weapons, including one SLR (Self-Loading

Rifle), one 303 rifle, 12 bore year, he said. rifle, 315 bore rifle, BGLs (barrel grenade launchers) and explosives, items of daily use and other Maoist-related materials were recovered from the spot, IPS officer Sundarraj said.
