Economy bucks trend of global instability: RBI bulletin

PRESSURE POINTS. Report cautions against trade policy uncertainties, tariff barriers

Various high-frequency indicators for May 2025 point towards resilient economic activity in India across industrial and services sectors. even as the global economy is in a state of flux due to trade policy uncertainties and a spike in geopolitical tensions, according to the RBI's latest monthly bulletin.

Overall economic activity remained robust in May 2025, with indicators like E-Way bills, Goods and Services Tax (GST) revenue, toll collections and digital payments showing strong growth

"GST revenue collections surpassed the ₹2-lakh-crore mark for the second consecutive month in May, boosted by import-related GST receipts. Petroleum consumption expanded for the first time in the last four months, driven by petrol. Unseasonal rains and premature onset of monsoon, however, led to a reduction in electricity demand," said the RBI staff in

Capacity utilisation by manufacturing firms re-mained above its long-period average, per the article, which also included comments from Deputy Governor Poonam Gupta.

MIXED SIGNALS

"High-frequency indicators for May present mixed signals on aggregate demand. Urban demand showed signs of moderation as passenger vehicle sales declined with a sharp drop in entry-level segment.

"High-frequency indicators of aggregate demand for May also suggested a pick-up in rural demand (as evident from the increase in the retail sales of two-wheelers),

especially given the strong performance of the agricul-tural sector," the authors said.

"Forward-looking surveys of consumer sentiments show stable consumer confidence for the current period and improved optimism about the future. All of these indicate considerable resilience of the Indian economy, notwithstanding the global economic, trade, and geopolitical uncertainties," the staffers said.

The authors noted that domestic inflation remains benign with headline inflation remaining below the (4 per cent) target for the fourth consecutive month in May (to 2.8 per cent, the lowest since February 2019, from It says that domestic inflation remains benign with headline inflation below the (4%)target for the fourth consecutive month in May

"Record domestic crop production in 2024-25 agricultural season is translating into a sharp and sustained easing of food price inflation. Steady core [Consumer Price Index (CPI) excluding food and fuel] inflation, with indications of some softening after excluding the im-pact of volatile and elevated gold and silver prices, indicates that underlying inflationary pressures remain muted," they said. The staffer cautioned that

protracted trade policy uncertainties and rising trade barriers pose the risk of scarring the global economy. The intensifying geo-

political tensions, too, may further debilitate the already weakened growth impulses.

In this context, the trade policy outcomes in July, after the temporary tariff hiatus is over, and the future course of geopolitical events would likely shape the mediumterm economic prospects.

This contrasts with the general belief that issuance of CDs is dominated by PVBs to complement their current and savings account (CASA) deposits, Anshul, Priyanka Priyadarshini and Dipak R Chaudhari said in an article 'Drivers of CD Issuances: An Empirical Assessment', published in the RBI's latest monthly bulletin.

"It has been observed that during the Covid-induced liquidity surplus phase, private banks were front runners in issuing the CDs; however, after February 2022, PSBs dominate the share in CD issuance."

"Foreign banks and relat-91 ively new Small Finance Banks (SFBs) have limited presence in the CD market. CD rates are higher for SFBs while PSBs were able to raise CDs at relatively lower rates," the officials said.

SBI appoints 5 lead arrangers for QIP issue for token fee of ₹1

The State Bank of India is understood to have selected five investment bankers to manage its ₹25,000 crore qualified institutional placement (QIP) issue, sources said.

Citigroup, HSBC, Morgan Stanley, Kotak Capital, and ICICI Securities have made it to the final list to manage the issue by charging a token fee of ₹1 for the issue, said sources with direct knowledge of developments. Sources added that a number of investment bankers had placed bids to manage the issue, but those quoting the rock bottom rate got the mandate. Citigroup declined to comment on the matter, while Kotak, HSBC, Morgan Stanley and ICICI Securities did not respond by press time.

4 dead, 3 injured in fire at five-storey building in Delhi

PTL NEW DELHI: Four people died and three got injured in a fire that broke out at a five-storey building housing multiple manufacturing units in Rithala area of Delhi's Rohini, police said on Wednesday.

Sixteen fire tenders were rushed to the building, located in Rohini Sector-5 area, after the fire department received a call regarding a blaze there at around 7.30 pm on Tuesday, officials said.

Delhi Fire Services chief AtulGarg said the incident was reported from a premises located near Rithala Metro Station.
